This item was discussed following agenda item 4.

14. Consideration/approval of sales contract between IDC Acquisitions, LLC and Rowan County Board of Education for property located at 2230 Flemingsburg Road, Morehead, Kentucky

Superintendent Maxey noted that this property is located across from Walmart. It is the location of the Collins Community Park. IDC Acquisitions, LLC is out of Tennessee and would like to purchase this property for \$1.5 million. The contractor would like to turn around and donate the ball fields back to whomever we decide we would like for them to go to. There are 17 acres of property at this location. The contractor basically wants about 5 acres that fronts Walmart along highway. Superintendent Maxey said he thought this was a win-win for the community and for the board. This land was originally designated for community recreation and we would like to take that money and turn it right back in to community recreation by creating a ball field or something on our campus. Chairman Whelan noted he thought that we could move the baseball field and get tennis courts on our campus. M.S.U. tennis courts were only a band aid fix and will probably be gone in one to two years anyway. Superintendent Maxey noted this is a great opportunity for the community and Rowan County Schools. Superintendent Maxey commented that when the community park was originally developed back in 1986 there was a grant that came out of the federal government that set aside money for the community park. One of the agreements was if the property was ever sold, we take that money and put it back into something related to community recreation. That is one of the reasons that generated discussion about what were we going to do with that money. The money will be put back into ball fields, tennis courts, and possibly a walking track. There are several things that can be done that will benefit the community.
